

How to reach the location?

From Amsterdam Airport Schiphol:

- Take a train to Den Haag Central Station (30 minutes)
- Take bus 24 to Kijkduin (on the central bus platform), stop at "Vredespaleis". NIBC is located opposite to the tram/bus stop. The journey takes about 10 minutes and the bus runs every 10 minutes
- You can buy a single train ticket at the station and a separate bus or tram ticket but it is more convenient to travel with public transport in The Netherlands with an OV Chipcard (similar to the Oyster Card in London). You can buy one at Schiphol Airport at the NS counter in the central arrival hall. The people at the counter will explain you how it works
